## ETTON PARISH COUNCIL

14 September 2020

**PRESENT:** Councillors Holmes (Chair), Armstrong, Bell, Gibbs, Sleight, Stott and Yeo.

Ward Councillor Greenwood attended for item 43-44.

Apologies were submitted from Councillors Widd.

Clerk: Alan Bravey.

The meeting was held virtually using Zoom.

**40/20 DECLARATIONS OF INTEREST** – There were no declarations made.

**41/20 CHAIRMANS UPDATE** – The Parish Council was saddened to hear about the recent passing of former Parish Council Vice Chairman and long term councillor, Phillip Wright. Councillor Holmes had written to Mrs Wright on behalf of the Parish Council to express condolences and record appreciation for Mr Wright's public service and dedication towards the community.

**42/20 MINUTES OF PREVIOUS MEETING – Resolved** – that the minutes of the Parish Council meeting held on the 13<sup>th</sup> July 2020 should be amended to correct the date of the meeting, and to clarify the position on grant funding, and then should be approved as a correct record and signed by the Chairman.

**43/20 WARD COUNCILLOR UPDATE** – Ward Councillor Greenwood gave an update on the draft local plan, and the changes coming from the Government's consultation on the future of planning.

**44/20 STREET NAMING POLICY** – The meeting reviewed the East Riding of Yorkshire Council street naming policy, following the recent naming of a new street in the village. The policy recommended that all new developments of two properties or more that were set away from the main road should be allocated their own street name. The developer was required to choose the name and could either pick from a pre-approved name bank, which had been the case for Appleton Ford, or carry out a wider consultation if they wanted to propose a different name. Etton name bank was made up of local people who had fought in World War One. The Parish Council felt that it was important to remember those who fought in the War, but that choosing street names in this way without any further context on the individuals involved had the potential to create upset within the village, particularly for the relatives still living in the area. Councillor Greenwood commented that she was also looking into a street naming issue.

**Resolved** – i) that the Parish Council would submit a list of new names to East Riding of Yorkshire Council to replace those already in the name bank, with emphasis given to more historical figures and geographical features ii) that Councillor Greenwood would provide a future update to the Parish Council on her investigations into Council street naming approach.

**45/20 CLERK UPDATE** – East Riding of Yorkshire Council had advised that a full road closure of Main Street was the only feasible way of carrying out the proposed drainage works. They had reviewed the traffic flow information for the village and felt that the diversion route would be able to cope with the additional traffic, but agreed to monitor when the scheme was introduced. Councillor Bell had agreed to act as a link officer with East Riding of Yorkshire Council over the works. Star Inns had not responded to the letters sent regarding the Light Dragoon and it was agreed that the Clerk would contact the area manager directly. The Parish Council thanked

Councillor Yeo, Mr Bugg and Mr Lofts for their work in weeding and tidying up the front of the pub, as well as on Chantry Lane, which was considered to have been a big improvement.

**46/20 PARISH COUNCILLOR FEEDBACK** – The Heritage Lottery Scheme would not reopen until least January 2021, which meant further work could not take place on the project, other than submitting planning application for the Willows, registering the pond land with Land Registry and finalising the bid form. Councillor Holmes had instructed the Parish Council gardener to tidy the area in the interim, and also to submit a review contract for future works. Councillor Holmes was working on dog fouling signs. The meeting discussed the condition of the paint on the village benches on Warter Road, and of the Church gate and Church Walk gate. It was agreed that Councillor Holmes would obtain a quote for the works and that Councillor Yeo would inspect the Church gate and Church Walk gate to see whether he could address these.

## 2. What's happening in Your Area

**Vehicle crime** – Several reports of vehicle crime across both Wards last month, of which a parked and secure vehicle on Burden Road had eggs thrown at the passenger side window. In addition a vehicle had its paintwork keyed and another vehicle had its front windscreen smashed, Malton Road area. Meanwhile across Minster & Woodmansey Ward there were at least 4 reports of vehicles being damaged by a sharp implement to cause deep scratches to the paintwork of said vehicles.

**Burglary reports** – 3 reports of business burglaries across Minster & Woodmansey during September of which Colletta & Tyson have been targeted, stealing power tools from within. Beverley Leisure Centre was also entered after hours setting the alarm off.

**Residential reports** – 5 reports across both Wards last month, 2 of which were attempts made. Across Minster & Woodmansey there was an attempt break in to a detached garage. Another garage was successfully entered off Basil Drive, stealing several items of property from within. An unoccupied property off Lyndhurst Close was broken into by using a crowbar or similar to force open the back door of the house. In addition a boat was entered, Riverview Road and a 12V battery was stolen to the value of £100.

## **Crime Prevention Advice following recent Scams**

### **CORONAVIRUS SCAMS**

#### **Track and trace scam**

A new telephone scam is coming. *This has been copied from a member of the public off Facebook*

YET ANOTHER SCAM BUT THIS ONE IS QUITE CLEVER SO PLEASE READ TO THE END.

Just got a call from my banks fraud prevention unit. Nice fella called Lukas. Kind enough to send me through a text under my banks umbrella text number to prove he was genuine and legitimate. Told me how my account was being fraudulently used in Birmingham and confirmed the last 4 digits of my account number. Reiterated that he didn't need my full account number or pin as he was going to cancel my card, for my own safety. I'd get a new card out in 3 days. As I said, very nice, very genuine sounding and very convincing. All he needed me to do was call out the code sent to my phone.

If I had've called out the code, which my actual bank had sent me as a warning that someone was trying to authorise a large purchase through my account, that code would have allowed him to proceed with the transaction and I would have been up the proverbial creek without a paddle. As such, when I told him I'd ring him back, he became much more insistent, saying that he hadn't asked me for my full account number or pin and was in fact helping me.
